

**FIRST AMENDMENT TO THE INTERLOCAL DITCH MAINTENANCE AGREEMENT
BETWEEN PINELLAS COUNTY AND THE CITY OF PINELLAS PARK**

THIS FIRST AMENDMENT (“First Amendment”) to the interlocal DITCH MAINTENANCE AGREEMENT BETWEEN PINELLAS COUNTY AND THE CITY OF PINELLAS PARK dated December 17, 2020 (“Agreement”), is entered into this ____ date of _____, 2026, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter the “COUNTY”, and the City of Pinellas Park, a municipal corporation of the State of Florida, hereinafter the “CITY”; collectively the COUNTY and the CITY are referred to as the “Parties.”

WHEREAS, the Parties entered into the Agreement on December 17, 2020, recorded at Official Records Book 21341, Pages 1-12;

WHEREAS, the COUNTY held a perpetual drainage easement (“Easement”) recorded in Official Records Book 11158, Pages 1720-1723, a copy of which is attached to the Agreement;

WHEREAS, the Agreement was for the COUNTY to maintain a ditch (“Ditch”) within an area of the Easement exclusively for drainage inflow and outflow in accordance with the terms of the Agreement;

WHEREAS, the COUNTY transferred the remaining portion of the Easement to the CITY via an Assignment of Easement, recorded in Official Records Book 21600, Pages 1108-1114;

WHEREAS, the Agreement expires five (5) years from the date of execution by both Parties; and

WHEREAS, the Parties wish to extend the Agreement for an additional five (5) years.

NOW THEREFORE, the Ditch Maintenance Agreement between Pinellas County and the City of Pinellas Park, recorded at Official Records Book 21341, Pages 1-12, is amended as follows:

The term of the Agreement is extended an additional five (5) years.

All other provisions in the Agreement shall remain in full force and effect.

This First Amendment will be effective upon execution by both parties and filing with the Clerk of the Circuit Court pursuant to F.S. § 163.01(11).
