WHEREAS, the City Council wishes to add definitions for Bars, Dance Halls, and Nightclubs;

WHEREAS, the City Council wishes to modify the definition of "Taverns and Lounges" to include bars, dance halls, and nightclubs, add retail and restaurants as accessory uses, and provide the ability to host food trucks; and

WHEREAS, the Planning and Zoning Commission, sitting as the Local Planning Agency, and the City Council for the City of Pinellas Park, Florida have reviewed and held public hearings on said proposed ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF PINELLAS PARK, FLORIDA:

II. CASE SUMMARY

The proposed change to the Land Development Code would add "Bars", "Dance Halls", and "Nightclubs" to the list of definitions in Section 18-1502.2. In addition, the definition of "Taverns and Lounges" would be modified to include bars, dance halls, and nightclubs, add retail and restaurants as accessory uses, and provide the ability to host food trucks.

III. APPLICABLE CRITERIA / CONSIDERATIONS

A. Land Development Code Standards:

Current Definition of Taverns and Lounges per Section 18-1502 (Definitions):

TAVERNS AND LOUNGES. Any place of business that sells or dispenses alcoholic beverages for consumption on-premises and derives fifty (50) percent or more of its gross revenue from the sale or dispensing of alcoholic beverages.

Proposed Additions and Changes to Section 18-1502 (Definitions):

TAVERNS AND LOUNGES. Any establishment (including bars, dance halls, and nightclubs) used primarily for the sale or dispensing of alcoholic beverages for consumption on-premises. The use may include retail and restaurants as an accessory use, and may host food trucks.

BARS. See "TAVERNS AND LOUNGES"

DANCE HALLS. See "TAVERNS AND LOUNGES"

NIGHTCLUBS. See "TAVERNS AND LOUNGES"
