

RESOLUTION NO. 2026-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA SUPPORTING REHABILITATION OF MASTER LIFT STATION 30; AUTHORIZING THE CITY MANAGER TO SIGN AND SUBMIT ATTESTATION FORMS AND BACKUP DOCUMENTS TO THE FLORIDA HOUSE OF REPRESENTATIVES FOR FISCAL YEAR 2026-2027 HOUSE APPROPRIATIONS FUNDING; DESIGNATING THE CITY MANAGER OR HIS DESIGNEE AS THE OFFICIAL LIAISON AGENT; CONFIRMING THE AMOUNT OF GRANT FUNDS REQUESTED; CONFIRMING THE CITY'S COMMITMENT FOR A CASH MATCH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Public Works Department provides residents, businesses and visitors with the highest level of health and public safety services while preserving the environment; and

WHEREAS, the Public Works Department, so as to provide continuous and reliable service, identified the need for the rehabilitation of Master Lift Station 30; and

WHEREAS, the City of Pinellas Park, Florida, will prepare the Appropriations Project request to the Florida House of Representatives for Fiscal Year 2026-2027; and

WHEREAS, appropriations funding through the Florida House of Representatives is contingent on a local cash match; and

WHEREAS, the Mayor and City Council support these improvement Projects as necessary for the safety and well-being of residents; and

WHEREAS, the Mayor and City Council intend to apply for Appropriations funding through the Florida House of Representatives; and

WHEREAS, the Mayor and City Council wish to authorize the City Manager to sign and submit attestation forms and backup documents to the Florida House of Representatives for these Projects.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1: That the Mayor and City Council of the City of Pinellas Park, Florida authorizes the City Manager to sign and Attestation forms and backup documents to the Florida House of Representatives for Appropriations funding of the Projects.

SECTION 2: That the City Manager or his designee is hereby designated as the official liaison agent for the grant application.

SECTION 3: That the City of Pinellas Park, Florida is hereby requesting funds in the amount of \$750,000.00 from the Florida House of Representatives for projects as attached hereto and incorporated herein as Exhibit A.

SECTION 4: That the City of Pinellas Park is committed to provide matching funds in an amount no less than 87.5% of the total project cost.

SECTION 5: That this Resolution shall be in full force and effect immediately after its passage and approval in the manner provided by law.

Project: Rehabilitation Lift Station 30

State Agency: Department of Environmental Protection

Abstract: The primary purpose/goal for rehabilitating Master Lift Station #30 and replacing its force main is to increase flow potential, volume, and pumping efficiency which will mitigate the risk of sewer overflow and associated pipe failures in the environmentally protected Roosevelt Wetland area and to ensure that the infrastructure is adequate to sustain the rapidly increasing growth in one of the City's and County's major commercial and residential activity centers - the Gateway Centre.

Estimated Project Cost: \$5,982,944

Total Appropriations Request: \$750,000

Local Match: \$5,232,944
