WHEREAS, the City of Pinellas Park requests to amend sections of the Land Development Code to remove minimum building separation requirements and add references to the Florida Building Code separation requirements;

WHEREAS, the Planning and Zoning Commission, sitting as the Local Planning Agency, and the City Council for the City of Pinellas Park, Florida have reviewed and held public hearings on said proposed ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PINELLAS PARK, FLORIDA:

SECTION ONE: That Section 18-1506.4, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended to read as follows:

Sec. 18-1506.4. DIMENSIONAL AND AREA REGULATIONS.

(H) MINIMUM BUILDING SEPARATION. Must meet Florida Building Code separation requirements.

SECTION TWO: That Section 18-1507.4, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended to read as follows:

SECTION SEVENTEEN: That Section 18-1523.4, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended to read as follows:

(F) MINIMUM BUILDING SEPARATION. Must meet Florida Building Code separation requirements.

SECTION TWENTY: That Section 18-1528.4, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended to read as follows:

Sec. 18-1528.4. DIMENSIONAL AND AREA REGULATIONS.

Except as provided under the regulations for conditional uses, the City Council shall determine the appropriate lot sizes, building height, <u>building separation</u>, yard setbacks, off-street parking provisions, signage, and other provisions that are adequate to meet the intent and requirements of these regulations, and further that such uses are harmonious to the adjacent uses and to the area. The following maximum intensity standards shall apply:

- (A) MAXIMUM LOT COVERAGE. Fifty (50) percent.
- (B) MAXIMUM FLOOR AREA RATIO. Fifteen hundredths (0.15).

SECTION TWENTY-ONE: That Section 1530.17, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended to read as follows:

Sec. 18-1530.17. MINIMUM BUILDING SEPARATION. RESERVED

- (A) In order to ensure adequate light, air and privacy, and in order to prevent the perception of crowding, when a lot is developed with multifamily dwellings or multiple buildings on a lot, as determined by the City Manager, or with a mixed-use development, principal buildings shall be separated as required below, based upon building height. If adjacent principal buildings on the same lot are not the same height, the height of the tallest building shall be used to determine the minimum required building separation. This distance shall be measured at the shortest distance between any two (2) buildings.
 - 1. Fifteen (15) feet of separation for buildings up to and including fifteen (15) feet in height.
 - 2. Twenty (20) feet of separation for buildings greater than fifteen (15) feet in height and up to and including twenty-five (25) feet in height.

- 3. Twenty-five (25) feet of separation for buildings greater than twenty-five (25) feet in height and up to and including thirty-five (35) feet in height.
- 4. Twenty-five (25) feet of separation plus one (1) foot for each one (1) foot of building height above thirty-five (35) feet.
- (B) Roofs, breezeways, and similar features are not considered to structurally connect buildings, and shall not exempt any two (2) or more buildings from compliance with this Section.

SECTION TWENTY-TWO: All other provisions of Chapter 18 of the Code of the City of Pinellas Park not hereby amended shall remain in full force and effect.

SECTION TWENTY-THREE: The provisions of this Ordinance shall become and be made a part of the Land Development Code of the City of Pinellas Park, Florida, and the publisher of the Code of Ordinances may renumber, reclassify or otherwise insert this Ordinance in an appropriate place to accomplish such intention.

SECTION TWENTY-FOUR: If a Court of competent jurisdiction at any time finds any provision of this Ordinance to be unlawful, illegal, or unenforceable, the offending provision shall be deemed severable and removed from the remaining provisions of this Ordinance which shall remain in full force and intact.

Our office would recommend updating the beginning of the Ordinance title to read as follows:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA, AMENDING THE CODE OF ORDINANCES OF THE CITY OF PINELLAS PARK, BY AMENDING CHAPTER 18, LAND DEVELOPMENT CODE, TO REMOVE MINIMUM BUILDING SEPARATION REQUIREMENTS AND ADD REFERENCES TO THE FLORIDA BUILDING CODE SEPARATION REQUIREMENTS; AMENDING

Similarly, please update the first Whereas clause to specify:

. . . the City of Pinellas Park requests to amend sections of the Land Development Code to remove minimum building separation requirements and add references to the Florida Building Code separation requirements.
