WHEREAS, the City of Pinellas Park requests to amend tables of the Land Development Code to remove "Health Spas" as a permitted use in various zoning districts;

WHEREAS, the City of Pinellas Park requests to amend sections and tables of the Land Development Code to add and establish regulations for "Health Clubs" and "Fitness Classes"; and

WHEREAS, the Planning and Zoning Commission, sitting as the Local Planning Agency, and the City Council for the City of Pinellas Park, Florida have reviewed and held public hearings on said proposed ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PINELLAS PARK, FLORIDA:

SECTION ONE: That Section 18-1502.2, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended so that said section shall include the following new and/or modified definitions in their proper alphabetic sequence:

Sec. 18-1502.2. - DEFINITIONS.

(B) Words or terms beginning with the letters "F" through "K":

FITNESS CLASSES. A facility offering class-based fitness programs with a limited number of participants that are instructor-led. These facilities are not considered "Schools of Non-Academic Curriculum."

HEALTH CLUBS. An indoor facility offering memberships that primarily focuses on individual fitness or training. It typically provides exercise classes, fitness equipment, a weight room, and/or spa. These facilities may include ancillary facilities, such as a swimming pool, whirlpool, sauna, limited retail and snack bar, and basketball, tennis, pickleball, racquetball, or handball courts.

SECTION NINE: That Chapter 18 of the Land Development Code of the City of Pinellas Park, Florida is hereby amended creating a new subsection 18-1530.32, which said subsection shall read as follows:

Sec. 18-1530.32. - HEALTH CLUBS USE.

- (A) PURPOSE. The intent of the Health Clubs use, where allowable, is to provide a membership-based facility within the community that primarily focuses on individual fitness or training. It typically provides exercise classes, fitness equipment, a weight room, and/or spa. These facilities may include ancillary facilities, such as a swimming pool, whirlpool, sauna, limited retail and snack bar, and basketball, tennis, pickleball, racquetball, or handball courts.
- (B) APPLICABILITY. Health Clubs are permitted on any lot of record within the "B-1" General Commercial, "CH" Heavy Commercial, "M-1" Light Industrial, "IH" Heavy Industrial, "MXD" Mixed Use District, and "TC" Town Center Zoning Districts.
- (C) ESTABLISHMENT. Health Clubs Uses shall be allowed as per the regulations of the applicable zoning district, as well as the other applicable regulations of this article.
- (D) GENERAL REQUIREMENTS.
 - 1. Outdoor fitness activities are prohibited.
 - 2. No overhead, sliding, or other type of similar doors shall face abutting residential zoning districts.
- (E) BUILDING SEPARATION. Must meet Florida Building Code separation requirements.
- (F) WAIVERS.

- 1. In any case where the strict application of the requirements of this Section presents an undue hardship, the City Council may waive one (1) or more of the requirements.
- 2. In determining whether to waive any requirements, the deciding authority shall consider the following criteria: character of the immediately surrounding neighborhood; size, configuration, and natural features of the land and development; and traffic impacts.

SECTION TEN: That Section 18-1531.10, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended creating a new subsection 34, with all subsequent subsections renumbered accordingly, which shall read as follows:

Sec. 18-1531.10. - LIST OF CONDITIONAL USES AND REQUIREMENTS.

(A) The following is an alphabetical listing of the special requirements for all conditional uses. This section authorizes, through the use of the term "administrative approval," the Zoning Director to review and approve certain conditional use applications if the applicant complies with all of the applicable criteria. For any application on which the Zoning Director acts, the applicant may choose to have the application reviewed and acted upon by the City Planning and Zoning Commission and City Council.

34. Fitness Classes.

(a) Administrative approval.

(b) When abutting and/or functionally abutting a residential zoning district, the following regulations shall apply:

- 1. No overhead, sliding, or other type of similar doors shall face abutting residential zoning districts.
- 2. Ten (10) foot wide landscaped buffer along abutting residential zoning districts, with a solid six (6) foot fence, a continuous hedge, and one (1) tree per twenty-five (25) linear feet of perimeter area, or fraction thereof.
- 3. Outdoor activity areas shall be at least fifteen (15) feet from abutting residential zoning districts.
- 4. Hours for outdoor activities shall be limited to 7:00 a.m. to 10:00 p.m.

SECTION ELEVEN: That Section 18-1532.9, of Chapter 18, of the Land Development Code of the City of Pinellas Park, Florida is hereby amended so that said section shall include the minimum offstreet parking space requirements in its proper numerical sequence:

Sec. 18-1532.9. - MINIMUM OFF-STREET PARKING REQUIREMENTS.

- (B) COMMERCIAL/BUSINESS USES.
 - 23. Health Clubs/Gyms: One (1) per one two hundred fifty (150200) SF of GFA.
 - 40. Fitness Classes: One (1) per two hundred (200) SF of GFA or by approval of the Planning & Development Services Director.

SECTION TWELVE: All other provisions of Chapter 18 of the Code of the City of Pinellas Park not hereby amended shall remain in full force and effect.

<u>SECTION THIRTEEN</u>: The provisions of this Ordinance shall become and be made a part of the Land Development Code of the City of Pinellas Park, Florida, and the publisher of the Code of Ordinances may renumber, reclassify or otherwise insert this Ordinance in an appropriate place to accomplish such intention.

<u>SECTION FOURTEEN</u>: If a Court of competent jurisdiction at any time finds any provision of this Ordinance to be unlawful, illegal, or unenforceable, the offending provision shall be deemed severable and removed from the remaining provisions of this Ordinance which shall remain in full force and intact.

SECTION FIFTEEN: This Ordinance shall be in full force and effect immediately after its passage and approval in the manner provided by law.
