

RESOLUTION NO. 24-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA SUPPORTING THE CITYWIDE LIFT STATION EMERGENCY ALTERNATE POWER PROJECT; AUTHORIZING THE CITY MANAGER TO SIGN AND SUBMIT AN ATTESTATION FORM AND BACKUP DOCUMENTS TO THE FLORIDA HOUSE OF REPRESENTATIVES FOR FISCAL YEAR 2025-2026 HOUSE APPROPRIATIONS FUNDING; DESIGNATING THE CITY MANAGER OR HIS DESIGNEE AS THE OFFICIAL LIAISON AGENT; CONFIRMING THE AMOUNT OF GRANT FUNDS REQUESTED; CONFIRMING THE CITY'S COMMITMENT FOR A CASH MATCH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Pinellas Park, Florida will prepare a grant application for an emergency alternate power project; and

WHEREAS, the Mayor and City Council support the emergency preparedness project as necessary for the safety and well-being of residents and the environment; and

WHEREAS, the Mayor and City Council intend to apply for Appropriations funding through the Florida House of Representatives; and

WHEREAS, the Mayor and City Council intend to authorize the City Manager to sign and submit an attestation form and backup documents to the Florida House of Representatives for the Citywide Lift Station Emergency Alternate Power Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA, AS FOLLOWS:

SECTION ONE: That the City of Pinellas Park, Florida is hereby requesting funds not to exceed \$750,000.00 from the Florida House of Representatives for the Citywide Lift Station Emergency Alternate Power Project as attached hereto and incorporated herein as Exhibit A.

SECTION TWO: That the City of Pinellas Park is committed to provide matching funds in an amount no less than 50% of the total project amount.

SECTION THREE: That the City Council of the City of Pinellas Park, Florida, authorizes the City Manager to sign and submit a grant application to the Florida House of Representatives for Appropriations funding of the Citywide Lift Station Emergency Alternative Power Project.

SECTION FOUR: That the City Manager or his designee is hereby designated as the official liaison agent for the grant application.

SECTION FIVE: That this Resolution shall be in full force and effect immediately after its passage and approval in the manner provided by law.

FY 2025 - 2026 Appropriations Project Request

Citywide Lift Station Emergency Alternate Power

Abstract: This is a citywide emergency preparedness project. The City of Pinellas Park is proposing to purchase and install permanent stationary generators for six (6) critical infrastructure lift stations and one tiger dam for lift station 31.

Power outages during hurricanes and other extreme weather conditions can disrupt lift station operations, causing pump shutdowns, loss of system control and potential overflows. Without a continuous power supply, wastewater cannot be effectively transported to higher elevations, resulting in system overflows.

The primary goal of this project is to mitigate lift station disruptions during power outages. Consequential outcomes of this project include preventing sewage overflows due to power outages which will prevent property damage, flooding, environmental contamination and public health risks.

Total Project Cost: \$1,500,000

Total Appropriations Request not to Exceed: \$750,000

Dear Ms. Hillier:

We have received today the above-referenced Grant Application with the request that it be reviewed immediately in order to be on the Agenda going out next week for the next Council meeting. We would offer the following comments:

1. In the title, I believe that the term "attestaion" needs to be changed to "attestation."
2. In the current Section One, we would suggest that it be changed to read:

That the City Council of the City of Pinellas Park, Florida, authorizes the City Manager to sign and submit a grant application to the Florida House of Representatives for Appropriations funding of the Citywide Lift Station Emergency Alternative Power Project.

3. I note that the amount of the Grant Application as stated in Section Three at the bottom of page 1 is \$750,000.00, of which the City is doing an equal match, and note on Exhibit A that the total project cost is stated to be \$1,500,000.00. However, on Exhibit A, the "Total Appropriations Request not to Exceed" amount is \$760,000.00. My assumption is that the \$760,000.00 is a typographical error and



needs to be changed to \$750,000.00, and wanted to bring that to your attention for correction if my assumption is correct.

4. For better continuity, I would suggest that the numbering of the Sections after the "Now Therefore" paragraph be changed as follows:
 - A. That existing Section Three be changed to be Section One.
 - B. That existing Section Four be changed to be Section Two.
 - C. That existing Section One be changed to be Section Three.
 - D. That existing Section Two be changed to be Section Four.
 - E. That existing Section Five remain as Section Five.

With consideration of these changes, we would approve of the proposed Resolution as to form and correctness.
