CDBG funds will be used to continue the Harmony Heights Safety and Mobility Project (\$325,635) and for Planning and Administration costs (\$50,000).

C4 <u>AUTHORIZATION FOR PURCHASE UNDER TIPS CONTRACT 230901</u> - Audiovisual Presentation System for Fire Administration Training Room - Fire Department
