The OMEGA plate takes ballistic performance to new levels. This National Institute of Justice .06 Level III ICW plate has been independently tested with both Level IIIA, II and Ballistic/Stab Soft Armor systems. This armor system will provide officers with protection from commonly encountered rifle threats such as .223, .762, and .308. This equipment is exceptionally lightweight, thin, can be worn by officers at all times and provides superior protection against special threats. Currently, the PPPD lacks the resources to put altogether the necessary systems to effectively respond to and prevent against special threats.

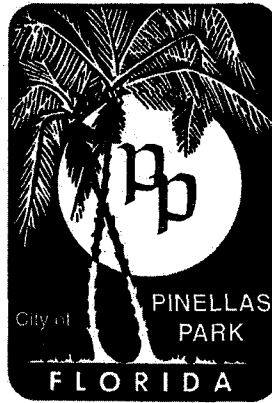
