- C4 **78TH AVENUE COMPLETE STREETS CONCEPT PLAN**

NOTE: City staff has been working diligently with Fehr and Peers, the Consultant for the 78th Avenue Complete Streets Concept Plan, to prepare a concept plan for 78th Avenue between 66th Street and US 19. This project was largely funded with a \$100,000 planning grant from Forward Pinellas.

At the May 11th City Council Workshop, the preferred concept was refined and applied to the full length of the study corridor. A report has been prepared detailing alternative project elements, project phasing and cost estimates. The report will be used for reference throughout the phased construction of the 78th Avenue Concept Plan.
