

# DRAINAGE EASEMENT

(*"Party of the First Part" and "Party of the Second Part" are used herein for singular or plural, the singular shall include the plural, and any gender shall include all genders, as context requires.*)

**WITNESSETH**, That the said Party of the First Part hereby grants for and in consideration of the sum of ten dollars (\$10.00), and other valuable considerations, in hand paid by the said Party of the Second Part, the receipt whereof is hereby acknowledged, hereby grants and releases unto the Party of the Second Part a **Drainage Easement** over, under, across and through that portion of Parcel ID# 33/30/16/64782/000/1010, Property Address 6540 50th Street North, Pinellas Park, Florida, 33781, as further described below and depicted in Exhibit "A" (sketch of easement area) which is attached hereto and made a part hereof.

THAT PORTION OF LOT 101, ORCHID LAKE SUBDIVISION, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 35, PAGES 26-27, OF THE PUBLIC RECORDS OF PINELLAS COUNTY, FLORIDA, BEING FURTHER DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF AFFOREMENTIONED LOT 101, RUN NORTH 89°44'20" WEST 126.57' TO THE POINT OF BEGINNING; THENCE CONTINUE NORTH 89°44'20" WEST 22.50'; THENCE SOUTH 44°13'22" EAST 20.28'; THENCE NORTH 30°05'46" EAST 16.68' TO THE POINT OF BEGINNING.

A PARCEL CONTAINING 162.83 SQ. FT. M.O.L.

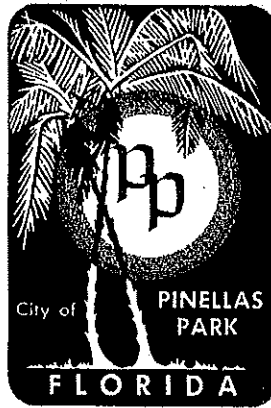
