

DRAINAGE EASEMENT

THIS INDENTURE, Made this _____ day of _____ A.D., 2019, between **Phi Phu Pham**, Mailing Address 6740 49th Way North, Pinellas Park, Florida, 33781, Party of the First Part, and the **City of Pinellas Park**, located at 5141 78th Avenue North, Pinellas Park, Florida, 33781, Party of the Second Part. (*"Party of the First Part" and "Party of the Second Part" are used herein for singular or plural, the singular shall include the plural, and any gender shall include all genders, as context requires.*)

WITNESSETH, That the said Party of the First Part hereby grants for and in consideration of the sum of ten dollars (\$10.00), and other valuable considerations, in hand paid by the said Party of the Second Part, the receipt whereof is hereby acknowledged, hereby grants and releases unto the Party of the Second Part a **Drainage Easement** over, under, across and through that portion of Parcel ID# 33/30/16/64782/000/0880, Property Address 6740 49th Way North, Pinellas Park, Florida, 33781, as further described below and depicted in Exhibit "A" (sketch of easement area) which is attached hereto and made a part hereof.

THAT PORTION OF LOT 88, ORCHID LAKE SUBDIVISION, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 35, PAGES 26-27, OF THE PUBLIC RECORDS OF PINELLAS COUNTY, FLORIDA, BEING FURTHER DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF AFFOREMENTIONED LOT 88, RUN NORTH 89°44'20" WEST 90.00' TO THE POINT OF BEGINNING; THENCE RUN NORTH 89°44'20" WEST 60.00'; THENCE SOUTH 00°29'13" WEST 50.00'; THENCE SOUTH 89°44'20" EAST 60.00'; THENCE NORTH 00°29'13" EAST 50.00' TO THE POINT OF BEGINNING.


