

Corrected as to City Ordinance No. in Paragraph Two

Dear Mr. Arrison:

I have received and reviewed the above-referenced Contract for sidewalks at England Brothers Park, which is a proposed piggyback of Pinellas County Contract Number 189 – 0118 – CP (JJ) with MTM Contractors, Inc.

After a review of all the items sent to our office, and a review of Pinellas Park's bid requirements in Section 2.602 of the City's Code of Ordinances, it would appear that the Contract between Pinellas County and MTM Contractors, Inc., was secured through a competitive bidding process which is equal to or more stringent than the competitive bidding process required by Pinellas Park City Code. The memorandum provided by the Purchasing Department confirms that they also believe this Contract may be piggybacked.

As long as the items or services that the City wishes to secure from MTM Contractors, Inc. are substantially similar and their pricing is in accordance with the pricing provided in the Pinellas County Contract, I am of the opinion that the Contract from Pinellas County is able to be piggybacked.
