Ms. Corna,

Below is the section of our By-Laws that explains the 5-year terms:

- a. Each Board member shall be appointed or elected for a term of five (5) years, except in the case of elected officials or their representatives, whose term shall end when the elected official is no longer in office.
- b. Board members may serve an unlimited number of five year terms, except in the case of elected officials or their representatives whose term shall end when the elected official is no longer in office.

Because the City of Pinellas Park is a governmental entity, the DEO requires that we obtain a letter of delegation each year, regardless of the number of years remaining in the 5-year term (see below). Mr. Holmes' 5-year term on our Board ends on July 31, 2020, which is the reason for my request. Per our contract, DEO states:

- *"One third of the members of the board are elected officials, holding office on the date of selection, or their representatives. Letters reaffirming the delegation, signed by the elected officials, shall be required each year regardless of the number of years the terms run."*

The letter submitted in January was the annual "delegation" letter. The letter I am requesting now reappoints Mr. Holmes' to another 5-year term. I hope this clarifies the matter for you. Please let me know if you have need of further information. Thank you and have a great weekend!
