## RESOULTION NO. 21-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA DESIGNATING THE CITY MANAGER AS THE CITY OF PINELLAS PARK'S AUTHORIZED AGENT FOR THE FLORIDA DIVISION OF EMERGENCY MANAGEMENT, MITIGATION BUREAU, HAZARD MITIGATION GRANT PROGRAM, FUNDED THROUGH THE FEDERAL EMERGENCY MANAGEMENT AGENCY; GRANTING SIGNING AUTHORITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Pinellas Park has been awarded a Hazard Mitigation Grant in the amount of \$618,750 from the Federal Emergency Management Agency (FEMA) to fund seventy-five percent of the total project cost for conducting activities that will protect Park Station against hurricane winds and for the installation of a new permanent generator; and

WHEREAS, the City of Pinellas Park's cost share for the Hazard Mitigation Grant is twenty-five percent of the total project cost (\$206,250); and

WHEREAS, the City Council designates the City Manager as the Authorized Agent and hereby grants said Agent signatory authority for FEMA Project Number 4337-337-R.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PINELLAS PARK, PINELLAS COUNTY, FLORIDA, AS FOLLOWS:

SECTION ONE: That the City Council of the City of Pinellas

Park desires to accept a Hazard Mitigation Grant funded through

FEMA in the amount of \$618,750.

SECTION TWO: That the City Council of the City of Pinellas

Park commits to a twenty-five percent cash match toward the total project cost of this Hazard Mitigation Grant.

SECTION THREE: That the City Council of the City of Pinellas Park hereby designates the City Manager, or his designee, as the Authorized Agent and grants signatory authority for FEMA Project Number 4337-337-R.

**SECTION FOUR:** That this Resolution shall be in full force and effect immediately after its passage and approval in the manner provided by law.
