Chief Haworth,

I was tasked with coordinating the planned replacement of our agency-issued GLOCK 21 handguns with new handguns under a pre-existing Capital Improvement Project. Our current GLOCK 21 handguns had been obtained circa September of 2006 and issued circa December of 2006. The original replacement cycle was slated for FY 19/20. Due to COVID-19 and other issues, this item was moved to FY 20/21 and increased in dollar amount to \$153,000 to accommodate additional items.

In working with Cpl. Osgood and the other firearms instructors, and in consultation with the agency armorers, we were able to determine a suitable replacement for our current handgun with a newer model of a different caliber, in addition to adding a more modern and capable sighting system, as well as providing plainclothes/off-duty holsters for all members.

A trial was conducted and it was determined that the best replacement candidate was the Generation 5 GLOCK model 17 9mm handgun, issued with a Trijicon RMR Red Dot Sight, Trijicon night sights, a Streamlight TLR-1HL weapon-mounted light, utilizing a Safariland 7TS series holsters in both a duty version for patrol and SWAT, and a separate paddle holster for off-duty and other official plainclothes uses. Magazine pouches were determined to be the same Safariland version as we are currently issued, modified to the selection of 9mm magazines, as well providing the option for the officer to select to carry 3 spare magazines instead of 2 if they so desired. Magazine holsters that also carry handcuffs were added for CIS personnel or others that may need them.

It was determined that the most effective way to proceed with the purchase of all of these items was to do a formal bid through the Purchasing Department. This would ensure that we had one vendor to provide all equipment, and that we were getting the best price. This bid would also include a trade-in value for our current handguns and weapon-mounted lights. Due to the addition of Tactical Medics to the SWAT Team, we would be expanding our handgun inventory from 114 to 120. It should be noted that we had

already obtained 2 fully outfitted weapons for use as a trial as well as for SWAT use, so this purchase would only require 118 handguns to fulfill the inventory needed.

Purchasing initiated bid 20/009 which was published and ended on 11-19-2020 at 1000 hours. Three bids were received, all of which appeared to meet the specifications listed in the bid criteria. The bids received were as follows, after trade-in value:

- Lou's Police Supply: \$123,821.50
- B&H Police Supply: \$140,553.05
- GT Distributors: \$143,639.53

Purchasing determined that Lou's Police Supply was the low bid and performed verification of references, as required in the contract, and obtained a check to keep as a bond in securing the bid.

In reviewing the bid for Lou's Police Supply, I see no issues with using them as our vendor and we have made many purchases from them in the past with no issues to note.

If you approve of this purchase as listed, I will create an agenda item for your review to be placed on the City Council meeting to be held on 1-28-2021.

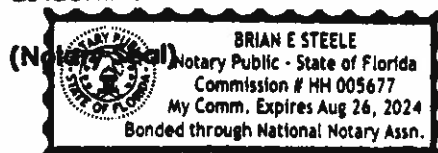

(b) In order to secure the right provided by this section, the person or persons continuing the business shall furnish the license for that business for endorsement of such succession to the Chief, FFLC, within 30 days from the date on which the successor begins to carry on the business.
